Starting at 6:30 AM for accurate information.

Early closings will be determined by 11:00 am.

Please call the snow number in the event that we have to cancel our program due to inclement weather.

If the Canton Public School cancels their after school programs Cole-Harrington will close and children will not return to our program. In this case parents will be responsible to pick up their child at their public school.

During inclement weather parents should call the snow emergency number throughout the day or as soon as you get the direct connect from the public school.

Cole-Harrington's Snow Day Policy

(Winter 2014)

Cole-Harrington is committed to staying open for parents who work. We are also ethically responsible for children's safety. Program coordinators will collectively decide opening and closing schedules based on the severity of each storm. Most often the "rule of thumb" will be if Canton Public Schools are closed, Cole Harrington's School Age Enrichment Program will be open **at 3 Randolph Street only**; from 8:00 a.m. to 4:00 p.m. with limited staffing. **We will be allowed one classroom at their program. The Galvin School program will be closed.**

To get the most accurate and updated information regarding Cole-Harrington's opening and closing schedules, please call our voice mailbox number 781-897-5724 . Snow Information will be on this voice mail by 6:30 a.m. Also, check this number by 1:00 p.m. on bad weather days to find out if we are closing early. Please keep this number with you.

Here's some additional information on our SNOW DAY POLICY:

Canton Public School closings are announced on WBZ Radio 1030 AM.

Cole-Harrington's School-Age site is closed on snow days. You may bring your school age child to the Children's Place facility at 3 Randolph Street given to the availability of space.

We reserve the right to close early if bad weather persists.

Staffing may be limited causing slots to be limited. Our cut-off point will be determined by using Early Education and Care's teacher/child ratio.

There will be no transportation on snow days if Canton Public Schools are closed, or if the school in your town is closed, or if the transportation company or Cole-Harrington coordinators deem it unsafe.

If Canton Public Schools delay opening, Cole-Harrington will not open until 8:00 a.m. unless weather and road conditions warrant a later start. We will close at our regular time. Transportation may also be delayed.

Please **DO NOT** call Mass Hospital School for information regarding Cole-Harrington's snow day schedule.

Mass Hospital School is not familiar with our SNOW DAY POLICY.

If the Governor declares a state of emergency, all Cole-Harrington programs will be closed.
